## What CPD opportunities are available through membership of COTSS-OP?

As a member of COTSS-Older People you are welcome to join, *for no extra charge*, one or more clinical forums relevant to your area of work. Currently our **clinical forums** include: **ACE** (Acute Care and Emergency), **Care Homes**, **Dementia**, **Falls**, **Intermediate Care** (including rapid response, reablement, home and bed based IC) and Mental Health & Young Onset Dementia.

Obviously from a CPD perspective it is not enough to just attend a training session/ study event, one must reflect upon it and change one's practice as the result of this. In the same way HCPC when they suggest membership of a specialist interest group as part of evidence of Professional activity, expect members to actively participate and *"improve the quality of your work"* or *"benefit service users"* as the result of this. And so **active participation as a COTSS-OP member will result in more relevant CPD opportunities and evidence.** Generally members gain more from membership by actively participating - thus getting benefits out of membership is in direct proportion to what they put into it.
